Dan Thomas, Shropshire Councillor for Much Wenlock, gave an update on funding plans for the Leisure Centre in Much Wenlock. The plans will improve the facility and make it more financially viable.

Two members of the public made comment about the Neighbourhood Plan, questioning if the Parish Council would be taking a lead on it and if there was any interest for the public at large. The £460 invoice for tree cutting at Harley by Cambers was questioned by the Parish Council and it was agreed that Cllr Matt Murray (Vice-Chairman) and Cllr Victoria Todd (Chairman) would meet with the contractor for private meeting about it.

Cllr Victoria Todd noted that there had been no invoices from Cressage Village Hall for room hire. Harley Village Hall charge £10 a session.

24.120 Other Parish Matters

- i. Village Gateway: there has been a site meeting with a technician from a company that sells village gateways (JACS). The resulting quote including delivery and installation is £4606. Councillors discussed this and considered that the financial position of the Parish Council included ample reserves to go ahead. However, it was agreed to seek additional quotes for installation costs and to consider this at the next meeting before making the final decision.

- iv. Harley phonebox: BT has plans to remove the payphone in Harley. The Parish Council can request that this does not happen. It was agreed that to request that the phonebox is not removed.
